



Maximize the Impact of Your Gift

Leverage your gift of \$250 or more with a 50% Colorado state income tax credit. Half of your donation will be offset by a dollar-for-dollar credit against your Colorado income taxes.

What is the Colorado Child Care Contribution Tax Credit?

The Colorado Child Care Contribution Credit (CCCCC) provides a valuable tax credit against a taxpayer's Colorado state income tax. The credit equals 50 percent of the amount of a contribution made to a qualifying Colorado charitable organization that promotes child care. Mackintosh Academy's Preschool (PreK program) qualifies us as a child care organization so we are able to share this tax credit with our donors who make a gift of \$250 or more and designate it for the CCCCC. It's a great way to double the impact of your gift! You can make a \$250 gift and essentially get back \$125 in a state tax credit, make a \$500 gift and get back \$250, make a \$1,000 gift and get back \$500, and so on. You may also be eligible for further federal and state deductions depending on whether you itemize. Please consult with your tax advisor to confirm how this will affect you.

If I make my Annual Fund gift through Colorado Gives Day can I still receive the tax credit?

Yes, gifts of \$250 or more made to Mack through the Colorado Gives website are eligible for the credit. There's actually a box and drop down menu at the bottom of the online giving form on the CO Gives website where you can select to "Consider this donation for Child Care Tax Credit." Go to www.cogives.org/macklitleton to make your gift.





If I decide to have my Annual Fund gift taken out monthly through Colorado Gives Day, can I still receive the tax credit?

Yes, if you decide to give that gift monthly you can still qualify for the credit but the credit you will receive will be for the payments on your gift that you made per calendar year. For example, if you pledge \$250, the payments you make in November and December will go towards your credit amount in 2019 tax year and then the remaining payments will go towards the 2020 tax year. As long as your original pledge/gift is \$250 or more you will receive the credits.

How do I indicate that I would like my gift to be eligible for the Colorado Child Care Contribution Credit?

Simply write CCCCC on your check and/or check the tax credit box on the Annual Fund gift envelope you should have received in the mail. Our Director of Development, Tami Vinson, will also be reaching out to families who make a gift of \$250 or more to inquire if they would like their gift to be eligible for the credit. What paperwork do I need to claim the credit on my taxes?

It's very simple! To claim the credit on your taxes you will just need to submit a copy of the Form DR1317 at the time you submit your taxes (you can do this with a hard copy or scanned copy via email or digital upload). We will be sending out the Form DR1317 (Colorado Child Care Contribution Credit tax form) to donors, who wish to receive the credit, in early January so that it is handy for 2019 tax preparation.
